Biography for Niall Lawless - Coach

Niall is a Chartered Arbitrator & Engineer, Adjudicator, Mediator. Niall is a Centre for Effective Dispute Resolution (CEDR) and a Chartered Institute of Arbitrators (CIArb) accredited mediator. Niall has been appointed mediator directly by the parties, the ICC, and also acted as mediator in disputes directed from the Birmingham Civil Justice Centre and the Central London Civil Justice Centre.

Niall has experience of acting as mediator in multi-million US\$ construction and engineering disputes. He is on the dedicated mediation panel for one of the largest construction and engineering projects in Europe. As Chair of the Construction Industry Council (CIC) Alternative Dispute Resolution (ADR) Management Board, Niall led the development of the CIC model mediation agreement and procedure, which was published in June 2019.

Niall is a Course Director, Tutor and Assessor on the CIArb Mediation Pathway to Fellowship. He has been a volunteer Judge and Mediator working as part of the 2nd, 3rd, 4th, 5th, 6th, 7th, 8th, 10th, 11th, 12th, 13th, and 14th ICC International Commercial Mediation Competitions. As a member of the Drafting Committee Niall wrote two culturally diverse dispute scenarios for the 2010 competition in Paris, and he was appointed judge for the final. Niall was a volunteer Judge and Mediator at the 1st ICC International Commercial Mediation Competition in Hong Kong, and he was appointed mediator for the final. Niall is also a CROCNAC certified and Mediation UK registered mediator actively involved in commercial and community disputes. Niall has acted as mediator on about eighty occasions.
